All of your items and your area should be cleaned by dusk, you are responsible for removing your trash off of the property.

Understand that this event is held at a working farm in the vineyard. Uneven ground and imperfections in mother earth exist. Be prepared to be outdoors. There are bugs, there could be wind or rain or cold weather. A bug could land on your neck. *GASP*

Booth Space may not be shared, each vendor selling goods at the festival must go through the application process.

Load In/Load out Instructions

The expectation is that you must be setup and ready for by 11:30 a.m.

Automobiles must be moved to general parking before beginning of festival.

Load out must be completed by dusk.

All trash must be removed off the premises with you.
